Acknowledgements

This monograph is the result of a trajectory which began with a Ph.D. course (“Scientific research: an impossible profession?”) at *Radboud University Nijmegen* in the 1990s (thanks are due to the participants). After my appointment (in 2000) as professor of philosophy of the natural sciences (*Faculty of Science, Radboud University Nijmegen*), I gave an inaugural lecture on scientific authorship (in 2001) and started a master’s course entitled *Science and Literature*, attracting only three participants at first, but I am grateful to the 600 or so science students (from a broad range of fields) who have read, discussed and analysed science novels in the context of this philosophical laboratory over the years. Although this book is not formally listed as a “deliverable”, I profited from collaborations and discussions as coordinator of a European H2020 project entitled PRINTEGER (*Promoting Integrity as an Integral Dimension of Excellence in Research*: GARRI-5-2014-1, project ID 665926), notably with the PRINTEGER team at Radboud University (Willem Halffman, Serge Horbach, Luca Consoli and Mohammad Hosseini), but also with other contributors to the project (which involves partners from eight European universities), especially Ruud ter Meulen (University of Bristol) and Dorian Karatzas (Head of the *Ethics and Research Integrity sector* at the *European Commission*). My gratitude is also due to the *Netherlands Research Integrity Network* (NRIN, notably Lex Bouter and Fenneke Blom), allowing me to present lectures on research misconduct novels in Amsterdam twice (during the *NRIN research conference* on 25 May 2016 and during the *World Conference on Research Integrity* on 29 May 2017). As to the conceptual framework and methodology, I profited intensely from dialogues with colleagues at our *Institute for Science in Society* (ISiS) committed to developing a continental philosophical approach to contemporary technoscience (Pieter Lemmens, Laurens Landeweerd, Jochem Zwier, Mira Vegter, Martin Drenthen and Andrea Gammon, but also regular guests such as Vincent Blok). I also thank the *Department of Philosophy/Centre for Critical Philosophy* at Ghent

University (notably Gertrudis van de Vijver and Jan de Vos) who invited me as visiting professor (in 2015) to explore connections between continental philosophy and contemporary science. And I want to express my profound indebtedness to Paul-Laurent Assoun, who introduced me to Lacan's "Gongorimso" in the 1980s: hitting my intellectual lifeworld like a meteorite (Assoun 2003, p. 4).
