Your group with 6 to 7 members assigned by the lecturer will write an essay about three different perspectives in regard to LAWS and ETHICS mentioned in our course. The topics is optional; however, you can reference the following advised topics:

#### LAWS

1. The Intersection of Corporate Governance and Stakeholder Theory. Provide an example in a Vietnamese business.
2. The Role of Corporate Social Responsibility to employees under Vietnamese labor code 2019. Evaluate a case study.
3. The Role of Corporate Social Responsibility to consumers under Vietnamese law on consumer protection 2023. Evaluate a case study.
4. The Role of Corporate Social Responsibility to shareholders under Vietnamese law on Enterprises 2020. Evaluate a case study.
5. Evaluating the changes of Law on Enterprise 2020 on Corporations
6. Evaluating the changes of Law on Enterprise 2020 on business reorganization
7. Evaluating laws on e-commerce transaction in Vietnam. Lessons from the US laws
8. Evaluating the principles of non-discrimination under the law on WTO. Provide a case study in the context of international trade.
9. What is consideration under contract law? Vietnam should require consideration as one of mandatory elements to form a contract.
10. Compare methods of dispute resolution in the context of international trade. Whether litigation is the most effective.
11. Explain Illusory Promise and the Mirror Image Rule under Contract Law? Evaluate a case study for each.
12. Explain Corporate veil under Business Law? Evaluate a case study.
13. Which elements is essential to form a contract under Vietnamese legal system?  
Evaluating some cases in breach of these elements
14. Exploring the role of patents and copyrights in promoting fair competition under Vietnamese legal system
15. Explore potential legislative changes and reforms that may impact how businesses are structured and governed in Vietnam.
16. Explore the concept of limited liability and how it varies across different business structures.
17. Analyze how emerging technologies, such as blockchain, AI, and the Internet of Things, are influencing Corporate Governance and Corporate Social Responsibility
18. What is product liability? Compare laws on product liability between Vietnam and the US legal system?
19. Analyze the functioning of the WTO's dispute settlement mechanism, its strengths, weaknesses, and its impact on international trade.
20. Investigate the role of the WTO in addressing the concerns and interests of developing countries.
21. Prove Vietnam is a socialist legal system. Compare Vietnamese legal system with a common law legal system like the US and a civil law system like France in terms of source of laws.

#### ETHICS

1. Explore and compare different leadership styles such as transformational, transactional, charismatic, situational, and servant leadership. Provide and evaluate some examples for each.
2. Impact of Leadership on Organizational Culture: Examine how leadership behavior shapes and influences the culture of an organization.
3. Leadership Training Programs: Analyze the effectiveness of various leadership development programs and their impact on individual and organizational performance.
4. Examine how leaders navigate ethical dilemmas and the impact of ethical leadership on organizational culture.
5. Analyze the relationship between leadership styles and the well-being of employees.
6. Examine the ethical dimensions of human rights issues in the context of global business operations.
7. Investigate how cultural differences impact ethical decision-making in the global business environment.
8. Investigate the ethical implications of global wealth inequality and its impact on social justice.
9. Examine the ethical dimensions of international trade agreements, considering their impact on different countries, industries, and communities.
10. Explore the ethical responsibilities of global businesses regarding environmental sustainability.
11. Explore strategies for fostering ethical behavior in multicultural and diverse business settings.
12. The Role of Independent Directors in Ensuring Corporate Accountability.

The group choose two topics for laws (max 5500 words) and one topic for ethics (max 2500 words)
